**MOTION FOR IMMEDIATE HOSPITALIZATION AND TREATMENT  
PURSUANT TO SECTION 552.050 RSMO.**


COMES NOW, the Missouri State Public Defender System, through Jan King, and respectfully requests an order from this Court transporting the defendant, Alyssa Bustamante, to the Department of Mental Health or other designated hospital to detain and treat Alyssa Bustamante for a period not to exceed ninety-six hours pursuant to Section 552.050 RSMo. 2007 Supp. In support, defendant states as follows:

1. Defendant Alyssa Bustamante is a fifteen year old child with no prior criminal offenses who was indicted yesterday, November 18, 2009, after having been certified to stand trial as an adult on the charges of Murder First Degree and Armed Criminal Action.
2. Defendant Alyssa Bustamante is demonstrating signs of severe depression and anxiety and has attempted suicide in the past.

3. Defendant Alyssa Bustamante is currently confined in the Morgan County Jail and under constant supervision and watch for fear of suicide.
4. Defendant Alyssa Bustamante is in need of immediate psychological treatment needed to assess her current mental state and to prevent the possibility that she may harm herself.
5. Counsel is not seeking a mental evaluation of defendant Alyssa Bustamante under sections 552.020 or 552.030 RSMo., at this time.

WHEREFORE, counsel for defendant respectfully requests an order from this court transporting the defendant, Alyssa Bustamante, to the Department of Mental Health or other designated hospital to detain and treat Alyssa Bustamante for a period not to exceed ninety-six hours pursuant to Section 552.050 RSMo.


